Application must be completed in full, with signature and full payment. FOR NEW MEMBERS BIRTH CERTIFICATES MUST EITHER ACCOMPANY APPLICATION OR BE RECEIVED BY THE WPRA OFFICE WITHIN THIRTY DAYS OR MEMBERSHIP AND POINTS EARNED WILL BE VOIDED. Applicant must be at least 18 years of age or the age of majority in the state/country in which the applicant is a citizen, whichever is greater. Applicant agrees to be bound by the Articles of Incorporation, Bylaws and Rules of the WPRA, as applicable. Applicant further acknowledges that participation in a rodeo as a competitor exposes the participant to serious risk of property damage, personal injury or death. Applicant assumes the risk of competition in any rodeo entered and expressly waives and releases any and all claims applicant may now have, or may in the future, for property damage, personal injury or any other claim which applicant now has, or may have in the future against WPRA, its officers, directors, employees, WPRA sponsors, the PRCA, or any WPRA/PRCA-sanctioned rodeo entity, their affiliated, related or subsidiary entities, any committee, any rodeo or barrel race producer, or production entity. This provision shall be binding upon applicant, her spouse, legal representatives including parents or guardians, heirs, successors, and assigns.

WPRA MEMBERSHIP IS SUBJECT TO COMPLIANCE WITH ALL WPRA RULES. COMPLETE AND UP TO DATE RULES ARE POSTED ON WWW.WPRA.COM. ALL PAPERWORK, INCLUDING A COPY OF YOUR BIRTH CERTIFICATE, MUST BE RECEIVED BY THE WPRA OFFICE WITHIN 30 DAYS OF SIGNING THIS APPLICATION.
